JERSEY IN 1881

The Raw figures

The 1881 Census recorded Jersey's population as 52,455, a fall of over 7% from 1871, and also the lowest recorded figure since the 1841 Census. By contrast the figures for Guernsey show a 7% rise in population during the decade since the previous census.

The fall in population across the island was, however, a very uneven one. One parish – St Saviour – actually recorded an increase in population of seven between the 1871 and 1881 censuses, and there were also increases in the enumerated male population at Grouville and St Ouen. The biggest fall in population was noted in St Brelade where the population fell by 21% between the two censuses.

At the time the historic divide between town and country parishes remained marked, with the population of St Helier accounting for just over 53% of the island's population – a slightly lower proportion than in 1871.

Of particular note is the fact that the decline in the number of females recorded was substantially greater than that of males. The former fell by 8.8% from 31,752 to 28,957, while the latter fell from 24,875 to 23,498, a drop of 5.5%.

In seeking to put these figures into some sort of context, we need to understand that Jersey's economy, after many years of growth, had hit choppy waters. The Jersey Mercantile Union Bank had failed in February 1873 with liabilities of £300,000, taking with it a Jurat sentenced to five years' imprisonment for fraud. In July the same year the Jersey Joint Stock Bank also failed, and although its directors were subsequently acquitted of wrongdoing, the losses incurred took a number of local businesses down. Combined with this was the general trend away from small sailpowered vessels towards larger ironclad steam ships, which saw a significant reduction both in local shipbuilding and in locally owned shipping. A mere nine vessels with a dead weight of 200 tons or over were registered in Jersey in 1881, and there were just four new registrations, with a combined tonnage of 167.

However, agriculture was about to receive a major fillip, for it was in 1880 that Hugh De La Haye planted two unusually large potatoes on a *côtil* at Bellozanne Valley and in early 1881 he harvested the first crop of what we know now as Jersey Royal potatoes.

Immigrants

The largest group of individuals born outside of Jersey were those born in England. In 1881 they numbered 7,055, or 13.4% of the overall population. If we add to them those giving their place of birth as Wales, Scotland, Ireland or the Isle of Man, we reach a figure of 8,697, or about one in six of the population. A further 901 individuals stated that their place of birth was within the Bailiwick of Guernsey.

The English-born were primarily urban dwellers¹. The largest concentration was in St Helier where they made up over 18% of the population, with significant numbers also in St Saviour and St Brelade. However in the northern parishes of Trinity, St John, St Mary and St Ouen they were very scarce, making up less than 2.5% of the population in each. The smaller Irish community was even more town-centric, with exactly 1,000 Irish-born residents in St Helier and just 271 in the country parishes – over 40 of whom were soldiers living in St Peter's Barracks.

Immigration to Jersey from Britain had peaked at this point. But the largest non-British immigrant community – those born in France – was continuing to grow. In 1881 4,259 individuals (8.1% of the overall population) recorded their place of birth as France. No fewer than 156 of these were under ten years old; the oldest of them was one of the two centenarians recorded in the census. This would only reflect in part the influence of the French community, as many Jersey-born individuals would have been the children of French-born parents.

Like the English, the French community was unevenly distributed: they were numerically sparse in St Brelade and St Ouen, but in five country parishes – St Mary, St Peter, St Lawrence, Trinity and St Saviour – the community exceeded a tenth of the population, and in St Saviour nearly one person in seven was French-born in 1881. In St Helier they numbered about 6.5% of the population, with a concentration in and around Hilgrove Street – that area is known to this day as *French Lane*.

Of the remainder, 430 individuals recorded their place of birth either in India, the East Indies or Ceylon – the largest concentration of these was found in the area of St Helier north of Rouge Bouillon, many of them the families of retired Indian Army officers. A further 200 were born in Canada, while between 50 and 70 were born in each of the USA and Australia.

¹ It is, however, worth noting that the St Helier and St Peter figures at least are distorted by the presence of major military barracks occupied by British Army regiments.

Notable events during 1881

January 6: The Centenary of the Battle of Jersey was celebrated. In the morning the Royal Militia of Jersey was reviewed at People's Park. The troops then marched to the Royal Square for a speech by the Lieutenant-Governor (thousands of civilians were also present). A procession comprising members of the Royal Court and the States then made its way to the Parish Church for a service of Thanksgiving. The States met to give a vote of thanks to her gracious majesty Queen Victoria. There followed a Militia Dinner, a States Banquet, a Municipality Banquet, a military banquet, illuminations, fireworks and balls. Lord Chelmsford (a relative of the family of Major Pierson) was in attendance

January 13: Deputy Godfray's *projet de loi* to remove the Rectors from the states was lodged *au Greffe* by 16 votes to 15.

January 14: The Rev PR Pipon Braithwaite was instituted and inducted into the Vicarage of St Luke.

January 17: A heavy snowstorm interrupted traffic on the Jersey Eastern Railway.

January 18: The all-island election of Deputies to the States took place.

January 20: The *Bothalwood* of Newcastle-on-Tyne, a 900-ton ship, was wrecked at L'Etacq, St Ouen. The crew of 17 were saved.

February 3: The States failed to reach a quorum and the sitting was abandoned.

February 14: An inquest took place on 14 year-old Claire Besnard, whose ill-treatment caused a public outcry.

February 21: Mr Francis Hawksford raised the *Clameur de Haro* as the *procureur* of Mr Frederick Nalder, claiming possession of the St Helier to St Aubin railway line.

March 1: The new weighbridge opened in St Helier.

March 12: James Toms was condemned at the Assizes to seven years' penal servitude for robbery with violence.

March 18: The new portion of Mont à l'Abbé Cemetery opened.

March 31: Rev George Clement, Rector of St Ouen, was instituted as an Honorary Canon of Winchester Cathedral.

April 26: Philip Baudains was elected as Constable of St Helier: John Vaudin was re-elected as Constable of St Saviour.

May 9: Alfred Fanton, a Frenchman who had been living for some two years in Hilgrove Lane and had a small clock-making business, was assassinated while he slept by his mistress Eugénie Toupin, who then committed suicide with a revolver.

May 14: Jacques Dumaresq of St Peter died aged 100. He was the last Jerseyman alive who was born prior to the Battle of Jersey.

May 20: A law was passed altering the management and administration of Victoria College.

June 4: John Way was sentenced to one month's imprisonment for highway robbery.

June 7: 1,072 loads of potatoes were weighed over the Public Weighbridge.

June 13: An important decision on a question of Seigneural rights was given by the Full Court, overturning the verdict reached by the Inferior Number on 11 December 1880. The decision related to whether the right to receive *rentes* reverted to the Seigneur of the fief for a year and a day should the owner die without natural heirs.

June 18: General William Booth (of the Salvation Army) arrived in Jersey.

June 26: Their Royal Highnesses the Duke and Duchess of Connaught arrived in Jersey. A man was *ducked* in the Harbour for ill-treating his son.

July 2: Adolphus Hilgrove Turner was sworn in as an Advocate.

July 5: The steamship *Claire*, serving the Jersey to Carteret route, arrived at Gorey.

July 13: Mr J Oldridge was appointed Sergeant of the Paid Police.

July 19: Messrs JA Seale and PJ Falle were re-elected as Constables respectively of St Brelade and Grouville.

July 31: The South Western Company's steam ship *Ella* made her first trip to Jersey.

August 4: A shipment of 175 head of cattle bound for America left the island.

August 23: The St Helier Parish Assembly voted in favour of erecting a monument to General Don in the Parade.

August 31: Jurat Langlois resigned on grounds of ill-health.

September 8: The States adopts the Law on the Importation of Cattle.

September 10: £500 was raised by a bazaar in aid of the new Zion Chapel at St John.

September 18: The funeral of Rev Guiramand, minister of the Roman Catholic Church at St Martin for over 25 years, took place.

September 29: The former Constable and sitting Deputy of Grouville, Thomas Filleul, died aged 73.

October 4: The annual Regatta took place at St Helier.

October 7: An inquest on 4 year-old Gertrude Briard returned a verdict of accidental death. She died of burns sustained when she went too close to a brazier which set her clothes alight.

October 11: Adolphus Hilgrove Turner was elected Deputy of Grouville, replacing the late Thomas Filleul.

October 14: The coal ship *Elizabeth Young* foundered *en route* from England to Jersey 40 miles off Flamborough Head. Three of the crew – Oliver Sage, George Tramp and George Le Chasseur – perished, but the other five were picked up by a fishing boat. The ship was insured by the Jersey Mutual Insurance Society.

October 20-27: Telegraphic communication with England was interrupted.

November 1: Senator Degeanetais and his wife were both condemned to three months' imprisonment with hard labour and five years' banishment for robbery.

November 5: Rioting took place in St Helier in connection with the Guy Fawkes celebrations.

November 14: A stone weighing 170lb was placed on the St Helier to St Aubin railway line in an attempt to derail trains.

November 16: Death of Moses Gibaut, the longest-serving Solicitor in Jersey (since 1822) at his home in St Saviour aged 84. He had also served 45 years with the Militia, retiring in 1859 as Colonel of the 1st (North-West) Regiment.

November 30: Col Bland was sworn in as Deputy Lieutenant Governor, Lt-Gen Nicholson being absent from the island.

December 1: The Jersey bull *Farmer's Glory* was sold in the USA for £600.

December 15: At the St Helier Parish Assembly, 214 requests for taverner's licences were recommended.

December 21: The annual Christmas Tea and distribution of clothing to the St Helier Ragged School took place.

Imports and Exports in 1881

The listing of imports and exports (reproduced from the *British Press and Jersey Times* almanac) shows marked changes in the island's economy since the previous census. The export of oysters, apples and cider from Jersey was still of some significance in 1871 but thereafter goes unrecorded. However, the export of potatoes and vinegar had grown substantially, and the export of stone and gravel had been established.

Figures cover the year to 30 September 1881.

District 7: Houses between King Street, Queen Street, Snow Hill, Hill Street, part of Mulcaster Street, Bond Street, top of Broad Street, Library Place and Brook Street, including Morier Lane, Vine Street, Royal Square and Church Street.

District 8: Houses between Conway Street, Bond Street, Pier Road, road at the back of Military Hospital (west), Old Quay, Victoria Pier, Commercial Buildings, Weighbridge and part of Esplanade, including Wharf Street, Cross Street, Hope Street, part of Mulcaster Street, Ordnance Yard and all lanes in Pier Road.

District 9: Houses between Pier Road, road at the back of Military Hospital (east), Havre Des Pas, Green Street, part of Hill Street and part of Mulcaster Street.

District 10: Houses between upper Hill Street, part of Colomberie, part of Green Street and Regent Road including La Chasse and Grenville Street. *Enumerator: Alfred Le Rossignol*

District 11: Houses between upper part of Colomberie, Roseville Street, Havre Des Pas and Green Street, including Limpet Lane and other lanes. *Enumerator: George Vautier*

District 12: Houses between Don Road, road leading to Rouge Rue, lane leading from Rouge Rue to Ruette Pavée, Grouville main road, St Clement's main road, the Dicq to the beach, Roseville Street and part of Colomberie including Hastings Road, Peel Road, Francis Street and lanes. *Enumerator: James H Henry*

District 13: Houses between part of Colomberie, St James Street, La Motte Street and Snow Hill including New St James Place. *Enumerator: A J Le Quesne*

District 7: The western part of the Vingtaine de Petite Longueville, from Plaisance west along the main road as far as Flinn's Public House and including all the houses to the south of the above named main road and also the houses north of the main road between the lower part of Belvedere Hill and the southern part of Mary Street, the area bounded on the south by the Parish of St Clement and the sea shore, on the west by the Parish of St Helier, on the north by District No 8, and on the east by the Vingtaine de Grande Longueville.

District 11: The Jersey Lunatic Asylum. *Enumerator: not recorded*

District 1: The northern part of the Vingtaine de Ville à l'Evêque, bounded on the north by the sea, on the west by the Parish of St John, on the east by the Vingtaine de Rondin and on the south by the main road from St John to Trinity Church, all houses on the northern side of said main road including the house near Petit Port and that occupied by Mr Josué Rondel. *Enumerator: Philippe Nicolle*

District 2: The southern part of the Vingtaine de Ville à l'Evêque, bounded on the north by the main road, on the west by the Parish of St John, on the east by the Vingtaine de Rondin and on the south by the Vingtaine de Croiserie and the Vingtaine des Augrès, all houses on the south of the main road including Mr Jean Blampied (Perruque), the Manor house and the three Lodges belonging thereto.

District 3: The northern part of the Vingtaine de Rozel, bounded on the north and east by the sea, on the west by the Vingtaine de Rondin and on the south partly by the Parish of St Martin and the main road from Trinity Church to said parish, including all houses bordering the main road and north of it, as well as that occupied by Mr Godfray near the Arsenal and the house on Rozel Pier.
